

Islamic Relief USA (“IRUSA”) Go Vote Graphic Art Contest Rules

- 1. General:** This contest is offered by Islamic Relief USA, 3655 Wheeler Ave, Alexandria, VA 22304. As a condition to being considered for the contest, you hereby represent and warrant that the following statements are true and correct and that you agree to these terms and conditions.
- 2. Eligibility:** Submissions must be from US residents who are 18 years or older. (If you are under the age of 18, your design must be submitted by a parent or guardian on your behalf.) Employees of IRUSA, its affiliates, or subsidiaries, and immediate family members and/or those living in the same household of such employees are not eligible to participate in the contest.
- 3. Submission Process:** Entries must be submitted with the entry form to publicaffairs@irusa.org. Only digital submissions will be accepted. The submission deadline is 11:59pm ET on June 1, 2024. There is no fee to enter the contest.
- 4. File Requirements:** Please design graphic art for a size of 2 x 2 inches. Accepted file formats: jpg, png or pdf. For quality reproduction purposes, the winning entry must later be submitted in scalable vector graphic format (EPS). Colors: IRUSA blue #0778d4 [and white]. Background: Transparent. Resolution: 300 ppi
- 5. Winner Selection and Notification:** The winning submission will be announced on June 14, 2024. You understand and agree that the winning submission will be selected by IRUSA based on originality, impact and adherence to the design criteria set forth herein and is a subjective determination. IRUSA reserves the right to make no selection of the submissions.
- 6. Graphic Art and Intellectual Property:** Your submission must be graphic art that encourages voting and includes the IRUSA logo. IRUSA hereby grants you a limited license to reproduce, use and create derivative works of the IRUSA logo solely in connection with this contest. Such license, however, may be revoked by IRUSA at any time in its sole discretion. Your graphic art must be your own original work that is not and has not been offered for sale anywhere by any means, and, other than the IRUSA logo, does not contain any trademarks, logos, copyrighted material, content subject to right of publicity or privacy, or any other intellectual property belonging to any third party. By submitting the graphic art to IRUSA, you hereby grant IRUSA the right and license to upload, modify, reproduce, copy, exhibit, create derivative works of, distribute, and display the graphic art, in any manner, in furtherance of IRUSA’s tax-exempt purposes. If the graphic art is selected by IRUSA, you shall assign the entire right, title, and interest in and to the graphic art to IRUSA.
- 7. What do you get out of it?** Fame! You will be credited as the artist. You will also get some free stickers incorporating your graphic art once they are ready and the gratification of supporting IRUSA’s efforts to encourage civic engagement in furtherance of its humanitarian relief work.
